Understand Your IRS Notice: What It Means, What To Do, and How GoTaxGurus Can Help

Why Am I Getting a Letter from the IRS?

If you've received a letter from the IRS, don't panic. The IRS sends letters for many reasons, and not all of them are bad. Common reasons include:

- A balance due
- A discrepancy in your return
- A request for documents
- A notice of audit or collection

△ Step-by-Step: How to Read an IRS Letter

- 1. Look for the Letter or Notice Number It's usually in the top right corner (e.g., CP2000, LT11, Letter 3572).
- 2. Find the IRS Department Contact Info In the top left corner, you'll see the IRS contact and phone number.
- Read the Reason for the Letter It may be about a balance, change, or request.
- 4. Locate the Response Deadline Usually near the top or bottom. Often 20 to 90 days.
- 5. Review the Action Steps You may need to call, write, pay, or attend an appointment.
- 6. Check for Enclosures Review all pages and attachments carefully.

	Most	Common	IRS	Letters	and	What	They	Mear

CP14

What it says: You owe taxes. This is the first bill from the IRS.

What to do: Review and pay or dispute. Don't ignore it.

Response Time: 21 days

Where to find help: Top right for notice number, top left for IRS phone number.

CP2000

What it says: IRS records show more income than you reported.

What to do: Review comparison. Dispute if incorrect.

Response Time: 30 days

Looks Like: Pages showing IRS income vs. your return.

LT11 / CP504

What it says: Final notice before levy.

What to do: Call GoTaxGurus. You may request a hearing.

Response Time: 30 days

Looks Like: Includes 'FINAL NOTICE' or 'INTENT TO LEVY'.

Letter 12C

What it says: IRS needs more info to process your return.

What to do: Submit missing forms or explanation.

Response Time: 20 days

Letter 3572

What it says: In-person audit appointment scheduled.

What to do: Call GoTaxGurus and do not go alone.

Response Time: Date provided on letter

Looks Like: Lists IRS contact, date, and location of meeting.

Letter 3219

What it says: Notice of Deficiency – tax will be assessed unless challenged.

What to do: Petition Tax Court if you disagree.

Response Time: 90 days

Looks Like: Includes 'right to petition the U.S. Tax Court'.

X How to Know If an IRS Letter is Real

- Comes via USPS Mail (not email or text)
- Has IRS letterhead and your (partial) SSN
- Includes letter number and IRS contact info
- Call IRS at 1-800-829-1040 to confirm, or contact GoTaxGurus
